INVESTMENT OBJECTIVE


The Securis Catastrophe Bond Fund ("SCBF" or the "Fund") aims to generate returns and growth by investing in catastrophe bonds ("Cat Bonds"). A Cat Bond is a form of insurance linked security that transfers the risk of financial loss as a result of catastrophic events to the capital markets. The sponsors of the Cat Bonds are typically insurance companies, reinsurance companies, corporations and governments. Cat Bonds may pay fixed, floating or variable rates of interest and typically have durations of between 1 and 4 years. Cat bonds may or may not be rated by an independent rating agency.

COMMENTARY - DECEMBER 20221

The Securis Catastrophe Bond Fund was up +0.64% in December 2022 taking the full year return to -2.25%.

The month saw a levelling-off of spreads, a reflection of a combination of price verification provided by eight series of notes pricing in the primary market and an improving balance between capital supply and demand.

SCBF chose to participate in three of the eight priced deals, acquiring exposures to California earthquake, a range of perils for a regionally focussed US insurer, and a dual-trigger US named storm and earthquake indexed protection. In the current tight market conditions we have the ability to be highly selective. We chose not to invest in the remaining five deals for various reasons including structural and pricing considerations. Instead, the Fund made a range of purchases in the secondary market where we were able to find value relative to the primary.

The most significant natural catastrophe event in December was the extensive severe winter weather, known as Storm Elliott, that affected much of the US and Canada towards the end of the month. Elliott has no impact on SCBF.

2022 has seen the Fund produce a negative annual return for the first time in its existence. While this is disappointing, it is encouraging to note that general spread-widening has been the predominant driver of performance, as opposed to underlying natural catastrophe activity, despite that in Hurricane lan we experienced one of the most significant events to occur during the existence of the cat bond market.

It now looks increasingly likely that the Fund will not ultimately suffer loss from lan and we finish the year with spreads on average around double the levels at which we started the year. As a result, we view the outlook as positive. Subject of course to future natural catastrophe activity, we would expect the year's negative performance to be recovered as maturing holdings pull to par and remaining uncertainty regarding lan losses ebbs away, while pent up sponsor demand should continue to underpin spreads.
