INVESTMENT OBJECTIVE


The Securis Catastrophe Bond Fund ("SCBF" or the "Fund") aims to generate returns and growth by investing in catastrophe bonds ("Cat Bonds"). A Cat Bond is a form of insurance linked security that transfers the risk of financial loss as a result of catastrophic events to the capital markets. The sponsors of the Cat Bonds are typically insurance companies, reinsurance companies, corporations and governments. Cat Bonds may pay fixed, floating or variable rates of interest and typically have durations of between 1 and 4 years. Cat bonds may or may not be rated by an independent rating agency.

COMMENTARY - JULY 2023

The Securis Catastrophe Bond Fund was up +1.48% in July 2023 taking the year-to-date return to +10.33%. Performance has been contributed to by higher levels of coupon interest, both in terms of risk-free return and risk premium, as well as some further spread tightening.

As is typical, July has been a quiet month. There were no primary issues launched during the month, while the secondary market experienced modest activity characterised by a surplus of buyers over sellers.

There were no natural catastrophe events of concern to the Fund during the month. Of course, we are now well into the North Atlantic hurricane season. It is not unusual for there to be no activity of concern during July. Looking forward, due to the conflicting influences of El Nino and very warm Atlantic Sea surface temperatures, there is more uncertainty this year than normal in forecasting. Our analysis nonetheless identifies areas of relative vulnerability in the context of which the Fund has positioned its portfolio. We will continue to monitor and react to developments as the season progresses.
