

INVESTMENT OBJECTIVE

The Securis Catastrophe Bond Fund ("SCBF" or the "Fund") aims to generate returns and growth by investing in catastrophe bonds ("Cat Bonds"). A Cat Bond is a form of insurance linked security that transfers the risk of financial loss as a result of catastrophic events to the capital markets. The sponsors of the Cat Bonds are typically insurance companies, reinsurance companies, corporations and governments. Cat Bonds may pay fixed, floating or variable rates of interest and typically have durations between 1 and 4 years. Cat bonds may or may not be rated by an independent rating agency.

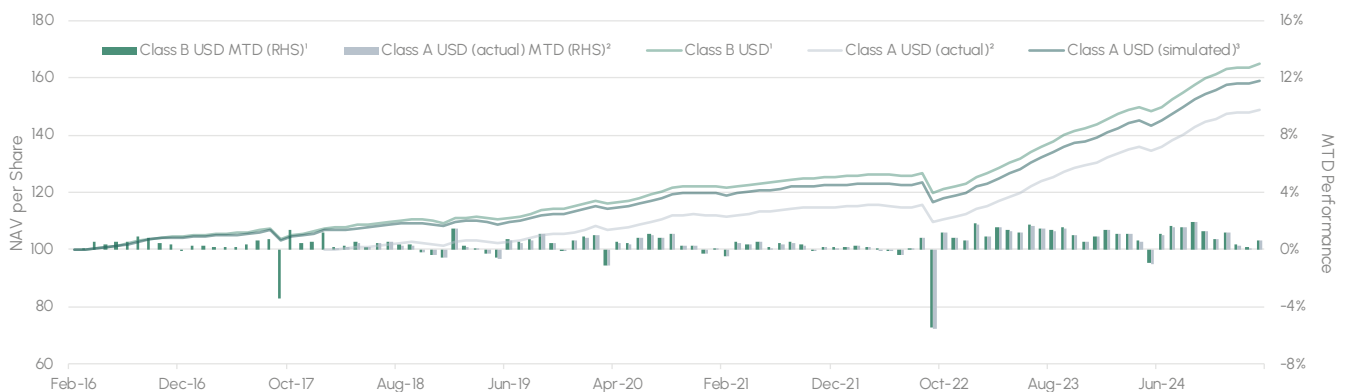

COMMENTARY – March 2025¹

The Securis Catastrophe Bond Fund was up +0.63% in March, bringing the year-to-date return to +1.05%. It has been another month dominated by primary market activity. A further nine programs of notes were launched, seeking to raise \$1.4bn. Overall priced deals for the year now amount to \$6.7bn, taking the total market outstanding to a record \$48.7bn (144a non-life bonds). The overall market weighted average spread widened over the month, driven by seasonal price reductions. This has, however, been a period of modest secondary market activity with many names not having traded for some time, introducing the possibility of price corrections as and when these names eventually trade.

The Fund invested in four of the month's transactions, acquiring exposures to US natural perils, Japan typhoon, and Florida named storm, all on an indemnity basis, as well as a North America index deal exposed to named storm and earthquake on a per occurrence basis.

At the start of the month, we attended the SIFMA Insurance Linked Securities conference in Florida. This is the long-standing annual get-together for the cat bond market. The event was well attended by established and prospective sponsors as well as, of course, the major broker-dealers who arrange and trade cat bonds. Impressions gained were of a positive market environment of continued and increasing sponsor interest.

The Fund does not have any exposure to the tragic Myanmar earthquake that occurred on March 28th. Once again, the pipeline of new deals is busy for the coming month—we are expecting to see a number of large and interesting transactions come to market.
