

INVESTMENT OBJECTIVE

The Securis Catastrophe Bond Fund ("SCBF" or the "Fund") aims to generate returns and growth by investing in catastrophe bonds ("Cat Bonds"). A Cat Bond is a form of insurance linked security that transfers the risk of financial loss as a result of catastrophic events to the capital markets. The sponsors of the Cat Bonds are typically insurance companies, reinsurance companies, corporations and governments. Cat Bonds may pay fixed, floating or variable rates of interest and typically have durations between 1 and 4 years. Cat bonds may or may not be rated by an independent rating agency.

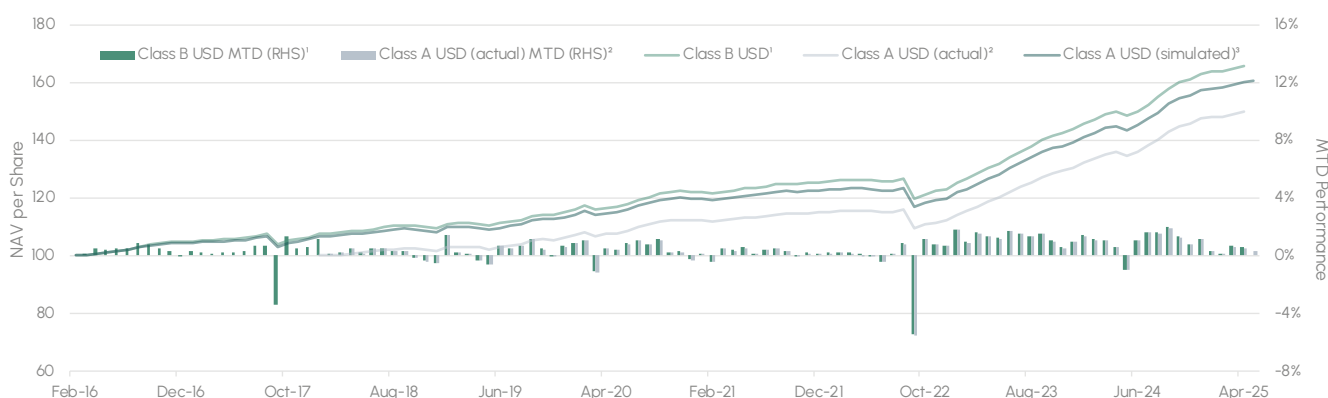

COMMENTARY – May 2025¹

The Securis Catastrophe Bond Fund was up +0.35% in May bringing the year-to-date return to +1.94%.

The pattern of the last few months continued into May. Modest price falls affected much of the market, once again driven by seasonality, however we observed less divergence between actual trade prices and book prices than we have seen in recent months, perhaps due to cash in the market being absorbed by continued large volumes of primary issuance. A further \$1.4bn of transactions were launched during the month, while \$3.3bn priced, taking the overall market size beyond \$52bn.

The Fund identified a wide range of investment opportunities amongst the primary issuance, investing in twelve tranches of notes. These included the 2025 series of one of the key programs the Fund has invested in over the years. These notes, which are exposed to a unique combinations of US perils, offer strong return potential in our view. Other investments included a European wind and earthquake deal, a number of US regional and nationwide multi-peril deals, and two tranches of Florida hurricane exposed notes.

Readers of this newsletter will recall that in the context of forecasts for a potentially highly active 2024 hurricane season, we adjusted the Fund's portfolio to be underweight relative to the cat bond market as a whole in hurricane exposures in Florida and the south east USA. Since the end of the 2024 season, we have been moving the portfolio to be more in line with overall market exposures, stressing that in this process we continue to be selective, focussing on those sponsors we consider to have robust portfolios and to be well resourced.

Forecasts for 2025, which are now emerging, are suggesting activity similar to average activity levels observed over the last 30 years. This view is driven by two principal physical factors, significantly cooled sea surface temperatures and a neutral state in the ENSO (El Nino/La Nina) cycle. In this context we are comfortable with the current portfolio positioning, recognising of course that conditions can change as we progress into the season and being prepared to make adjustments accordingly.
