INVESTMENT OBJECTIVE

The Securis Catastrophe Bond Fund ("SCBF" or the "Fund") aims to generate returns and growth by investing in catastrophe bonds ("Cat Bonds"). A Cat Bond is a form of insurance linked security that transfers the risk of financial loss as a result of catastrophic events to the capital markets. The sponsors of the Cat Bonds are typically insurance companies, reinsurance companies, corporations and governments. Cat Bonds may pay fixed, floating or variable rates of interest and typically have durations of between 1 and 4 years. Cat bonds may or may not be rated by an independent rating agency.



COMMENTARY - DECEMBER 2019⁴

SCBF was up +0.65% in the month of December 2019, bringing the return for the full year to +5.12%. By comparison, the Swiss Re Cat Bond Total Return Index (which carries more risk than SCBF) shows a gross return of +4.59% for the year. Looking back over 2019 we see the key elements that have influenced the Fund's performance as a lack of natural catastrophe events in the USA (although Hurricane Dorian caused concern at the time), price mark-downs, but not actual losses, as a result the Japan typhoon events of both 2017 and 2018, and the across the board and persistent fall in prices: the Swiss Re Cat Bond Price Return Index was down -1.98% over the year.

A corollary of price falls is widened spreads. The past six months has seen levels not experienced for six years. We believe this current level is sustainable. The fourth quarter of 2019 saw record levels of primary issuance, and sponsor demand continues to be strong. We understand there to be a full pipeline of primary issues in the months ahead, not only renewing positions, but also new sponsors, including sponsors from outside of the re/insurance sector. This is likely to be more than adequate to absorb the \$1.25bn of capital expected to be freed up from transactions maturing in January, whilst underpinning spreads. As such, we expect that attractive investment opportunities will arise, going into 2020.

This has been a busy month for both the Fund and the cat bond market as a whole. In the primary market five series of new issues priced, totalling \$1,900m. Towards the end of the year we tend to see a raft of insurance industry loss indexed securities coming to market, typically sponsored by purchasers of retrocession protection, and this month has been no different. From within the five series of notes brought to market. SCBF was able to identify and invest in accretive classes of each of the five. Four of these expose the Fund to various combinations of weighted index exposures in the USA, Canada, Caribbean, Europe and Australia (not including wildfire exposures). The fifth is a position in a highly structured California earthquake transaction, which has a number of interesting features: a parametric index trigger based on spectral acceleration values; a unique geographic distribution; sponsored by an investor in mortgage assets, new to the cat bond market.

There was no natural catastrophe activity of concern to the Fund during the reporting period. The Fund has no exposure to wildfire risk in Australia and so is not affected by the current widespread outbreak of bush fires.
